

FROM OUR STATE CHAPLAIN

Brother Knights and Ladies

Laetare! Rejoice! We are now close to the midway point of our Lenten journey. It seems like it goes by faster every year, doesn't it? So, our parishes that have catechumens are celebrating the Scrutinies with them as they prepare for their Easter baptisms. The gospel readings for the three weeks of the Scrutinies are all from the Gospel of St. John. We begin with the story of the woman at the well. Jesus meets a Samaritan woman at Jacob's well. This is a story of welcome and forgiveness. Jesus surprises the woman with His willingness to interact with her. Jews of that time looked down on Samaritans, but Jesus does not treat her as an outsider, rather he shows interest in her as he would a member of His own family. He offers her living water, which of course has a spiritual meaning that harkens to the baptism that He is bringing to the world. This helps our catechumens know that they are not outsiders but very important members of God's family: the church. The next week, Laetare Sunday, the Gospel that we hear from St. John is the story of the man born blind. Jesus heals the man by making a sort of clay from His saliva and the ground nearby. He then spreads it on the man's eyes and has him go to the pool of Siloam to wash it off so that he will be able to see. This happens on the sabbath so there are Pharisees that disapprove. They want answers and they question the man who has sight for the first time. We can see their lack of faith and the growing faith of the man born blind. Some even suggest that this is a different man who was not indeed born blind. They call in his parents who attest that he is their son who was born blind, but they are afraid to say how he came to be able to see because they depended on the good will of the Pharisees. Jesus has given the man his physical sight but, much more importantly, He has given him spiritual sight and understanding that comes with faith. The last gospel story is the raising of Lazarus from the dead. Jesus delays His trip to Bethany when He learns of Lazarus' illness and the request from Martha and Mary to come to Bethany to heal Lazarus. So many times, in our lives we have to wait on the Lord in prayer; this story helps us to understand that the Lord is there for us even when we must wait. When He arrives in Bethany, Lazarus has been dead for 4 days. He takes this opportunity to show His power and love for Lazarus by restoring him to his earthly life. Martha and Mary had given up on Jesus being able to help Lazarus other than on the last day. However, Jesus shows the power that the Father has given to Him. This shows us that Jesus is more powerful than we can even imagine. Let us pray for our catechumens, that they are inspired by these stories to greater spiritual sight, understanding and faith on their journey to the waters of baptism.

As you fill out those award forms, use the **FAITH IN ACTION guidebook** from the Supreme website as a guide. The **Fraternal Programs Report Form** will also help guide you through the process.

Once you have completed that process, please do us the honor of submitting your single best program or activity in each of the four (4) categories: Faith, Family, Community, and Life to the State Council for judging before the Wyoming State Convention being held in Cheyenne, April 26th through the 28th.

Award nominations are due to April 12th!

The Form State Council Service Program Awards Entry Form (#STSP) is the proper way to submit each of these entries for four categories. You are also encouraged to submit Wyoming State Family of the Year (form #10680) and the Wyoming State Knight of the Year (no form as it is a State Program). The links for the forms are listed below.

For the 2nd straight year the Knights are accepting the **State Blessed Michael McGivney Award** (form #SBMMA). A matter of courtesy and protocol it would probably be best to obtain the Priest's permission to nominate him.

We need to have the entries in early to judge the Faith, Family, Community and Life entries plus the Wyoming State Family of the Year and the Wyoming State Knight of the Year.

The Past State Deputies will conduct an on-line review and judging as we did last year. We found that the ability to see, read, and review the submissions with more time was beneficial. In the past when having to do these on an early Friday morning, many times we ran into and over some of the opening ceremonies at the Convention. Please note again the due date is April 12th.







I am excited to see the entries that will be submitted. You must always remember that when you spread the word about what you do, it is an encouragement to others. We do many good works for Charity, Unity and Fraternity. Please celebrate and share that Columbianism.


