FROM YOUR STATE CHAPLAIN

We were blessed to have had the opportunity to be fed by the sermon on the plain for the three weeks leading up to Lent this year. We hear at the beginning of the sermon on the plain from St. Luke's Gospel with the beatitudes and woes. Like it was for Jesus' time, it is a very countercultural message. We hear these days that we must grow our economy. We hear that we should aspire to be a wealthy nation. We hear that we should close our borders and protect our own. I do not see how these ideas could have been inspired by Jesus' teaching on the plain. I saw on Facebook recently a single sentence written by Pope Francis from a few years ago saying that countries have the right to secure borders. A commenter wondered if he remembered having said that. I try not get drawn into these "discussions" in social media, so I did not respond. Pope Francis most assuredly remembers having said that and he would say it again any day because it is completely based in Catholic teaching. However, our right to live in a country with secure borders does not give us the right to only care about the welfare of those who legally live within them. We are called to care for all of God's creation and do what we can to help each other. We should never get caught in the trap of thinking that others are somehow not worthy of receiving help. If Jesus' teaching on the beatitudes isn't hard enough, Jesus goes on to tell us to love our enemy and be merciful to them. Talk about radical teaching! We are called by Jesus to remember that God wants us to love the "other" in our world. He wants us to stop counting the cost and help those less fortunate than us, no matter who or where they may be. He points out how easy it is to treat those well that help us and make us prosperous. People that have not hurt us are easy to like. Jesus calls us to be merciful like His father in heaven. Well, if we are going to be merciful then we have to forgive those who have hurt us, who make us feel unsafe, and threaten our livelihoods. Jesus continues with parables about leadership, specifically about how a disciple of Jesus should lead others to also be disciples of Jesus. He then goes on to talk about the fruit that trees produce. A well-cultivated tree has a better opportunity to produce good fruit than one that is neglected. Just as a person has a better opportunity to be a good disciple of Jesus when they have been accompanied by good teachers of the faith. We do not hear the last few verses of the sermon. In those verses Jesus tells us about the importance of building our homes on solid rock foundation. Just as we should build our lives on the foundations of the faith that Jesus has taught us. When we only partially build our lives around Jesus' teaching, we are in danger of being swept away from Jesus by those other concerns just like a home built on sand can be washed away by a flood. The sermon on the plain gives us much to consider about how we can be good disciples. Let us be good disciples of Jesus Christ and work for all to have a dignified life.

The Form State Council Service Program Awards Entry Form (#STSP) is the proper way to submit each of these entries for four categories. You are also encouraged to submit Wyoming State Family of the Year (form #10680) and the Wyoming State Knight of the Year (no form as it is a State Program). The links for the forms are listed below.



RE: 2024 Tax Information for KofC Councils, Assemblies, & Chapters

This notice is to remind councils, assemblies, and chapters in the United States of their legal obligation to file an IRS Form 990 (informational tax return) for the 2024 tax year, and to provide detailed instructions on how to comply with this obligation.

The Knights of Columbus, including all subordinate councils, assemblies, and chapters (collectively referred to as councils), is a tax-exempt organization, recognized by the Internal Revenue Service as a fraternal benefit society under Section 501(c)(8) of the Internal Revenue Code. This tax-exempt status requires each council to file an annual Form 990 with the IRS.

Councils reporting gross receipts of \$50,000 or less with less than \$200,000 in assets may comply with their obligation by filing the Form 990-N electronic postcard (also known as the e- Postcard). Councils reporting gross receipts of more than \$50,000 and less than \$200,000 with total assets of less than \$500,000 must file the Form 990-EZ. Councils with gross receipts of

\$200,000 or more and total assets of \$500,000 or more must file the Form 990.

REMINDER

The IRS requires electronic filing for **all** tax-exempt organizations, regardless of which form they use. The online filing system, also known as "E-Services", requires **all new users** to register or sign in with LOGIN.GOV or ID.me, the current IRS credential service providers.

There are two ways to access the Form 990-N Electronic Filing system: (1) Sign in with your active IRS username; or (2) Sign in/create an account with LOGIN.GOV or ID.me. Form 990-N filers who have an existing IRS username and register for a new Login.gov or ID.me account must use the email address associated with their IRS account. Refer to User Guide for the IRS Form 990-N Electronic Filing System. Instructions are available on the IRS website, links to which are in the Where to File section, below.

During this tax season, we would like to remind you to beware of scams and fraud. The IRS has published information on how to identify scams and fraud and what you can do to protect yourself. Recognize tax scams and fraud | Internal Revenue Service

Deadline to file annual return (all forms)

Each council must file its own tax return; there is no group or consolidated Form 990 filing. The returns must be filed by the fifteenth day of the fifth month following the end of the council's annual accounting period. For example, if a council's accounting period ends December 31, it must file a tax return by May 15 of the following year; if a council's accounting period ends June 30, it must file a tax return by November 15. Please note that **the IRS assigns the accounting period to each council based on its Employer Identification Number** (EIN). The IRS **will not** notify the council of the accounting period. To determine the accounting period assigned to your council's EIN, sign into the IRS system with your user ID and password. For most councils, the assigned accounting period corresponds to the calendar year.





Need more time to file a Form 990?

Although the IRS does not grant extensions for filing the Form 990-N (e-Postcard), the IRS will accept late filings if the tax return is received within three years of the due date. While the IRS will accept late filings of Form 990-N (e-Postcard), please note that filing late, even within a three-year period, is still considered a missed filing by the IRS and may trigger a revocation of a council's tax- exempt status if for three consecutive years the council files late or fails to file a return. The IRS does grant extensions to organizations filing Forms 990-EZ and 990. If a council needs more time to file the Form 990-EZ or 990, it must request an extension by the due date of the return for which it is requesting an extension. Federal law imposes a penalty for late or incomplete filings. If an organization fails to file a required return by the due date (including any extension of time), it must pay a penalty of \$25 a day for each day the return is late. In general, the maximum penalty for any late return is the lesser of \$12,500 or five percent of the organization's gross receipts for the year. In order to request an extension, councils must submit Form 8868, which is available on the IRS website: http://www.irs.gov/pub/irs-pdf/f8868.pdf. For councils reporting gross receipts of more than \$50,000, we recommend using a qualified tax professional to file Form 8868.

Where to file

Form 990-N (e-Postcard)

The Form 990-N (e-Postcard) must be filed online.

The User Guide for the IRS Form 990-N Electronic Filing System is available here: USER GUIDE Form 990-N (e-Postcard)

The Form 990 e-Postcard Electronic Filing System is available here: CLICK HERE TO FILE Form 990-N (e-Postcard)

The Knights of Columbus Form 990-N e-postcard filing instructions are located on Officers Online (go to Officers' Desk Reference, Tax Issues, #6 Federal Tax Returns).

If you use the above link to file the Form 990N (e-Postcard) there is no filing fee, as it connects directly to IRS.gov.

Forms 990-EZ and 990

Forms 990-EZ and 990 must be filed online. The IRS website provides instructions for electronic filing of Forms 990-EZ and and 990: https://www.irs.gov/charities-non-profits/current-form- 990-series-forms-and-instructions

Any council reporting gross receipts of more than \$50,000 is strongly urged to consider using a qualified tax professional to prepare and file its tax return.

PRACTICE TIPS:

When filing, bear in mind that text fields cannot exceed 35 characters and must contain only numeric, alpha or hyphen characters. Periods, slashes and so on will cause filing errors.

At the top of the Form 990-EZ and Form 990, enter the Knights of Columbus group number (0188), tax exempt status (Section 501(c)(8)), and form of organization (Association). You may find e-filing instructions for the Form 990-N e-Postcard here: https://www.irs.gov/e-file-providers/e-file-for-charities-and-non-profits

If the IRS website will not allow you to file a Form 990-N

The electronic filing system for the Form 990-N (e-Postcard) may reject a council's return if: (1) the council's EIN has been revoked for failing to file for three consecutive years; (2) the council's EIN has recently been reinstated; (3) it is a new council; or (4) the council is not on the Supreme Council's Group Exemption List (updated continually by the Knights of Columbus Legal Department). If you are unable to e-file, please contact the Legal Department by email at tax.ein@kofc.org. You can also contact the IRS customer service at 1-877-829-5500.

Compliance Guide for Tax Exempt Organizations

In addition to the annual filing requirement, each council is responsible for conducting its affairs in a manner that is consistent with what is expected of tax-exempt organizations. Failure to do so may result in a council losing its tax-exempt status. In this regard, councils may wish to consult an IRS publication entitled *Compliance Guide for Tax Exempt Organizations*, which provides helpful guidance:





Earlier this month while listening to the Gospel in Mass, the reading was when Our Lord "recruited" Peter and Andrew. You remember the story. Peter and his men had been fishing all night long and they had caught nothing. Cast after cast and troll after troll they fished. Might they have said at some point, we have worked so hard and caught nothing, maybe we have caught all the fish and there are none left to catch.' Sound familiar? Then after they returned to the shore and were cleaning and repairing their nets, along came Jesus. And what does Jesus say? "Put out again into deep water." How crazy that must have sounded to them. As professional fishermen, they knew that you fished at night and not mid-morning, and you fished in shallower water where the fish schooled. Peter protested, politely but firmly: "Master, we have fished all night and have caught nothing but at you word we will put out into deep water." When they did, what happened? They caught more fish than they could imagine. When they returned to shore, nets nearly bursting, Peter made his confession — "Depart from me Lord for I am a sinful man." What did Christ say in return? Come, follow me and I will make you Fishers of Men.

He challenged them to put their faith into action. After they had felt the joy and wonder in this faithful action, they were open to his suggestion to follow him.

How do we become Fishers of Men in our families and Parishes? We meet a man where he is. We don't argue with his objections, but we invite him first to put his faith into action at one or our events. We let him live in the wonder of the moment and when we invite him to join us on our journey. This has always been the most successful way to recruit, one man asking another man, a parishioner, a friend and family member to experience what we have found in the Knights – feeding the hungry, clothing the naked, giving drink to the thirsty and visiting the sick and the imprisoned and then to come and join us. As we enter the Lenten Season, what better time is there to become Fishers of Men.





Prayer for the Canonization of Blessed Michael McGivney

Founder of the Knights of Columbus

God, our Father, protector of the poor and defender of the widow and orphan, you called your priest, Blessed Michael McGivney, to be an apostle of Christian family life and to lead the young to the generous service of their neighbor. Through the example of his life and virtue, may we follow your Son, Jesus Christ, more closely, fulfilling his commandment of charity and building up his Body which is the Church.
