Father talked about the Blessed McGivney 1st class relic that was part of a tour in Wyoming earlier this year. We will be passing out Blessed McGivney prayer cards for all the councils to take back to their membership and parishes. The cards touched the 1st class relic, which makes the cards 3rd class relics. Father reminded everyone to treat the cards with respect and dignity — don't use them as a coaster or lying around where they may get damaged or mistreated. Use them as a marker in your prayer book or bible or display them in the frame of a religious artwork or photo. If the card does get damaged, the proper way to dispose of it is by burying it or burning it.

Memorials Committee Chairman – GK Powell 3043

The names of 29 deceased members were included in the report to be read at the Memorial Mass

Credentials Committee Chairman - GK Rock Springs 2441

Zach Johnson, Chairman, reported that the committee had reviewed all delegate credential forms submitted. Nine council credential forms were missing the council seal and nine councils did not submit a credential form. The committee approved the credentials submitted by the 19 councils present.

Audit Committee Chairman – GK Buffalo 3332

Robert Fox, Chairman, reported that the committee recommends that the State Council accept the audit completed by Grooms & Harkins, dated January 23, 2025 for fraternal year 2023-2024. The committee reviewed the recommendations from G&H and believe the state officers have rectified the deficiencies in accordance with the auditor's direction. The committee also proposes that the State Treasurer, State Secretary, State Deputy and Immediate Past State Deputy continue to meet semi-annually to review current vouchers, check registries and QuickBooks to make sure all entries are true and correct.

Mileage/Per Diem Committee Chairman – GK Riverton 3237

Larry Higgins, Chairman, reported that the committee recommends that the State Council retain the current rates of \$90.00 for per diem and \$0.45 for mileage for the 2026 fiscal year. The committee also recommends that the Budget Committee and Mileage and Per Diem Committee meet prior to the convening of the 2026 State Convention to enhance the knowledge of the budget process and determine what mileage and per diem rate changes should be made, if any. Finally, the committee recommends that councils help defray expenses for delegates over and above what the per diem covers.

Budget Committee Chairman - GK Gillette 3477

Greg Gebhart, Chairman, reported that the committee agreed with the mileage and per diem committee to leave the mileage and per diem rates the same since this is the first year they are in affect. The committee reviewed the budget and determined it was in line with past budgets and thus recommend the budget be approved.

Larry Espelage, Chairman, reported that the committee recommends adoption of all sixteen (16) resolutions that were submitted.

District 4 includes Councils 2578 in Thermopolis, 3237 in Riverton, and 5447 in Lander.

Council 2578 is currently under the direction of Grand Knight Maynard Bills and meets the first Tuesday of every month at St. Francis Catholic Church in Thermopolis. Maynard and his Knights have taken a much greater leadership role at St. Francis since losing their Priest last year and becoming a "Mission Parish" in the Diocese of Cheyenne. The men now lead a weekly parish rosary on Fridays and provide ushers, extraordinary ministers, and lectors at their lone Sunday Mass. The Council conducted their annual "Beef Raffle during the past winter" and used most of the proceeds to support RSVP and multiple other local Thermopolis charities. Council 2578 also prepared and served weekly fish fry meals during the Fridays of Lent for parishioners and local town residents. Council 2578 participated in the Knight's "Coats for Kids" program for the first time in 2024, distributing coats to children in need through the local school district. Finally, the men conducted clean-up activities along a mile-long stretch of highway south of Thermopolis in Fall 2024 and maintain an active role in supporting Wyoming's St. Joseph Icon and Silver Rose programs.

Council 3237 is currently led by Grand Knight Larry Higgins and meets the second Tuesday of every month at St. Margaret's Catholic Church in Riverton. Mr. Higgins and his Knights support an amazing array of local charities by providing facilities and meals for the various group's fundraising activities. The Council is an active and major supporter of St. Margaret's Catholic School and Abba's House, a local crisis pregnancy center. Through their support of Abba's House, Council 3237 has become engaged in the K of C's ASAP program. Like Thermopolis, men of the Riverton K of Cs are engaged in parish ministries including extraordinary ministers, lectors, ushers, and members of the Parish Pastoral Council. Riverton Knights also support the St. Joseph Icon and Silver Rose programs and provide donations to Wyoming Seminarians through RSVP.

Lead by Grand Knight Gary Michaud, Council 5447 meets the first and third Mondays of every month at Holy Rosary Catholic Church in Lander. The first meeting is the Council's social meeting, while the second is held to conduct monthly business. Members of Lander's Council provided financial support to the K of C's Special Olympics program through the sale of Tootsie Rolls to local businesses and raised over \$2,200 in 2025. Lander's Knights are active participants in the K of Cs Silver Rose and St. Joseph Icon programs. The Council prepared and served Parish brunches during the Sundays of Lent. They also provided carnations and a Sunday brunch for mothers of Holy Rosary on Mothers' Day. A number of Knights organized and lead a weekly men's study group each Thursday morning and served in active parish ministries as extraordinary ministers, lectors, ushers, and members of the Holy Rosary Parish Pastoral and Finance Councils. Two Knights also serve as Holy Rosary Parish Lay Directors. Council 5447 participates in the K of C's "Keep Christ in Christmas" program by financing a downtown billboard which proclaims the Christian message of Christmas through an appropriate message and image of the Holy Family. Numerous members of Council 5447 participated (with students and faculty from Wyoming Catholic College) in the Annual March for Life in downtown Lander. The Council has also

- *This Council is bordering on unhealthy.
- *All Officer positions, required FIA Director positions, and Membership Director position are filled.
- *They are compliant on all SEP requirements.
- *They do not have a COR group, but do have members that attend the Parish men's group.
- *They do not have a Faith Director, Life Director, or EFF Director.

Brother Knights,

I am Dave Patterson from Saint Patrick's Church in Wheatland.

Brother Larscheid asked the Councils of Wyoming if they had anyone interested in Chairing the Coats for Kids Program for Wyoming. I've known Jim since we were kids, so I volunteered. I'm here today to give you a brief update on last years program and to encourage the Councils that did not participate last year to consider participating this year.

Last year fourteen Councils participated with 95 cases of coats ordered. There are twelve coats in each case, so that is 1,140 coats distributed to Wyoming kids that needed them.

Basically, how the system works is councils purchase coats through Supreme (via. Knightsgear.com) and by doing so, Supreme matches their order (buy one case, get one free). Supreme will deliver to five locations within each state. In 2024, they delivered to Gillette, Casper, Sheridan, Rock Springs and Cheyenne. It was up to the councils or District Deputies to pick up their orders. District Deputies were tasked with getting the orders from their councils and then transmit them to the state. This year that will be me. I will place the order for Wyoming. Each council will pay the state for the coats that they order.

The jackets come in child and youth size for both boys and girls with a cost of \$247.38 per case. Also, in girls' and boys' teen sizes with a cost of \$304.24 per case. Distribution of the coats was handled differently by each council. Some found a place where they could

put the coats on racks or tables and let the kids come in and pick out the coat. Other councils worked with the schools in their area and let them hand out coats to the kids that they knew needed them. Some councils took their coats to smaller towns that don't have many resources and had them distributed there.

Supreme highly encourages councils to distribute the coats on Black Friday. Councils will receive a notification to participate in August and orders should be sent to me by the end of September.

So, to the councils that participated last year, thank you. To those of you who did not participate last year I encourage you to consider doing so this year to help those who are less fortunate.

FAITH

Members of Council 7453 continue to support our ICC Parish by leading the Rosary before week-end Masses. We serve as ushers, lectors, greeters and take up the collection each week. We organized a 24-hr. Adoration for the 2024 Elections and had each 1 hr. time slot filled with at least two people and several people for some of the hours. We decorate outdoor trees around the Parish grounds each Advent with multi-colored solar lights, set up the outdoor manger and help in decorating the church interior. We have helped the parish with monetary support for Living and Giving in Christ Campaign. We support our Priest with Christmas and Birthday gifts each year. We have helped with church repairs, shoveling sidewalks and miscellaneous projects when requested. Members of Council 7453 assist in teaching CCD and Confirmation classes. St. Patrick's Council #9917 Grand Knight's Report 2025 – Jim Corkery

The past fraternal year has been a very active one for Council 9917. The council has supported our parish, Catholic school, Diocese, and community in numerous ways. Below is a summary of these efforts.

Parish Support

The council actively participated in several parish initiatives, including a program to support elderly parents and family members. This program, held on Monday evenings in Fall 2024, provided information on resources for elderly care. The Knights contributed by providing a light dinner for two of the six sessions, serving approximately 25 to 30 attendees.

Additionally, the council supported a Blue Mass (Recognizing First Responders) by organizing a pancake breakfast following the 10:30 AM Mass. During Lent, the council contributed to the Friday evening Soup & Bread meal after the Stations of the Cross. A significant parish event, the St. Patrick's Day celebration, saw the council leading the meal effort, preparing and serving a traditional Irish corned beef and cabbage dinner for over 200 attendees.

Financially, the council provided donations to the Parish Vocations Ministry, supporting the purchase of banners and a Christmas gift mailing to seminarians.

School Support

Council 9917 continued its strong support of St. Anthony's Catholic School. The Knights prepared and served the Archangel Breakfast, which hosted over 300 attendees. Additionally, the council purchased firearms for auction at the Partners in Education event, raising over \$11,000 dollars for the school. Several Knights attended the event, coordinating the auction and ticket sales.

The council also made substantial financial contributions to St. Anthony's School. This included a \$10,000 donation to support middle school students attending the John Paul II camp and additional funding for Bibles. Furthermore, the council donated \$1,000 to support improvements to the school's kitchen facilities.

Diocese Support

Council 9917 supported the Diocese in multiple ways. One key initiative was the Walk for the Eucharist event, where Knights participated as members of the 4th Degree, escorting

clergy and ceremonial participants. The Knights also contributed by cooking burgers for attendees.

The council continues to support the KOC RSVP efforts within the parish, hosting a monthly breakfast whose proceeds are sent to the Diocese to support seminarians. Additionally, the council made a significant financial contribution to the Diocese Communion Campaign, donating \$80,000 across Casper's three parishes: \$40,000 to St. Patrick's Church, \$20,000 to St. Anthony's Church, and \$20,000 to Our Lady of Fatima.

Furthermore, the council donated \$1,500 to the Diocese Totus Tous youth event.

Community Support

The council has undertaken several community initiatives over the past year. The largest of these is the **Coats for Kids** program, in partnership with a broader community effort. This past year, the council, along with other partners, provided over 700 coats to needy children and distributed toys to enhance their Christmas experience.

Annually, the council organizes, prepares, and serves a Thanksgiving meal in support of the Holy Cross Food Bank. This past November, nearly 200 meals were served, raising \$2,500 for the Food Bank.

The council also supports **St. Anthony's Manor**, a Catholic Diocese senior living community, by coordinating two events annually. The first, a Valentine's Day breakfast, is hosted for the residents, while the second, a summer barbecue, serves as both a meal and an outreach event.

Council 9917 remains committed to supporting **Right to Life** efforts. Each year, the council collects donations through baby bottle handouts during Right to Life weekend and supports the annual Right to Life March by serving breakfast after the walk. This year, the council also made a \$10,000 contribution to the organization's capital campaign. Additionally, members were privileged to tour the new Right to Life facility and witness firsthand how it supports expectant mothers in need.

The council also collaborated with Casper's other local council and the Assembly to conduct various initiatives such as Highway Cleanup throughout the year, strengthening our shared mission of service and charity.

Council 9917 remains dedicated to its mission of faith, service, and community support. We look forward to another year of meaningful contributions and fellowship.

The Budget Committee met on April 26th, 2025.

Last year the budget increased to \$90 per diem and 45 cents per mile. This being the first year it has been in effect, the committee has concluded that it was needed and at this time it has not caused a lot of problems with the financial outlay. We would suggest that we monitor the results of this change. Wyoming has the highest per capita assessment in the United States and a raise in per diem and mileage would cause a raise in our per capita. We recognize that each council should share in making sure that their delegates are properly funded to cover shortfalls.

All of the other proposals in this proposed budget are in line with the performance of the past budgets. An increase in membership should result in an increase in collected per capita. We are experiencing a loss in income as some of our inactive members have been transferred into affiliate memberships.

The mileage and per diem committee proposed increasing both mileage and per diem rates. We determined that there was not room in the budget this year for that increase. They reconsidered and agreed to leave the rates as they are for next year. We propose that the committees meet in tandem or be merged in the future.

We as a committee ask that you approve the budget we set before you.

CATHOLIC ETHICS IN LIFE LIMITING PRENATAL DIAGNOSES

ne of the most difficult challenges for parents experiencing a diagnosis is the often-traumatizing attachment of lethal language to the baby alive in the womb. Parents should understand that phrases such as "fatal fetal anomaly," "lethal or terminal prenatal diagnosis," and "incompatible with life" are not clinical terms. More often than not, medical researchers and ethicists suggest these labels tend to reflect the judgment that a life lived with a significant disability is not worth living. At diagnosis, lethal language may be used to encourage the uptake of abortion. Once lethality is attached to a baby, it may also serve to steer the parents who do not abort into limiting their medical options during the pregnancy, and at labor and delivery, and to make decisions before birth regarding the care of their child.

It is important that parents have the best, most medically accurate information to make informed decisions for their unborn child with a prenatal diagnosis. Fatal terminology conveys a false impression that a prognosis can be made with certainty prenatally. Not only is that untrue, but studies have found that when offered the same medical care as other babies at birth, newborns with disabilities like Trisomy 13 and 18 exceed previously assumed lifespans and outcomes. "Life limiting" is a better term that more honestly states what can be known about babies with certain prenatal diagnoses before birth.

Prenatal referrals for palliative care and/or perinatal hospice care with the mindset of limiting medical options for a newborn at birth should not be made unless it is known with moral certainty that the prenatal diagnosis is (1) accurate and (2) that it will directly cause perinatal death with or without life-sustaining treatment and care routinely offered to newborns. The primary reason for this is that medical decisions, which are moral decisions, must be made with all available knowledge.

In the majority of cases, the most accurate information regarding the diagnosis, prognosis, and possible treatment options for a baby with a prenatal diagnosis can only be gained with a full medical evaluation of the child by appropriate medical specialists after he/she is born. Parents, who are charged with acting in their child's best interests, have both the right and the duty to gain such information in order to make medically informed and ethically appropriate decisions concerning their child's medical care.

The evaluation of the living newborn is so important that efforts should be made to stabilize the child at birth, including intubation when necessary, unless the intubation itself is burdensome because an airway is abnormal and tube placement is excessively difficult. In some cases, medical providers may suggest that parents may determine that intubation is

unnecessarily burdensome if it appears probable that an infant's prognosis reduces the likelihood of future extubation, as may be the case if an infant has an encephaly. Even in such cases, parents should make the decision.

It should be noted that parents have the right to choose to forgo extraordinary treatment, but basic medical care is morally obligatory. An infant should not be denied basic care and proportionately beneficial life-sustaining treatments whose administration does not create an undue burden to the child. No infant should be allowed to die as a result of lack of nutrition and hydration or other basic care, such as the bandaging of exposed brain or organs, treatments like antibiotics, or other ordinary measures unless the benefits of any such measures are outweighed by the burdens, risks, or side effects from their administration. "Comfort care" protocols should meet this standard as well.

In addition, the assertion that feeding should be withdrawn because its administration creates disproportionate burdens to the baby should only be made following an appropriate medical evaluation. The typical infant who vomits following a feeding isn't then routinely denied any additional feedings.

To this extent, the living baby with a prenatal diagnosis (i.e., a significant disability) should be treated like any other infant. The rights of parents to provide for the basic needs of their child with a disability should be respected. Medical conditions that impact feeding should be discussed fully with parents, and all remaining options for the provision of hydration and nutrition should be explained to them.

Lethal language and the corresponding judgment against life-limiting conditions which may be characterized as uniformly "lethal" by medical providers, can impact the care of an infant in NICU. Medical providers may decide that the provision of supportive measures is futile in spite

of the wishes of parents. The placement of formal DNR (Do Not Resuscitate) orders in an infant's chart without parental consent violates the patient-doctor relationship in which the parent is presumed to speak on behalf of their child. A physician-initiated DNR denies parents informed consent and autonomy in decision-making regarding the care of their baby and may violate the parents' religious beliefs. It is also possible that an unofficial or verbal DNR order or not acting quickly if an infant is in crisis constitutes what some would term a "slow code." This is another means by which a medical team may disregard parental rights.

Relative to securing life-sustaining or restorative treatment, an understanding of the pediatric concurrent care provisions of the Affordable Care Act (ACA) may also be helpful for parents in advocating for their child. The ACA requires that all state Medicaid programs pay not only for hospice services for children under the age of 21 who qualify but also for treatment and care which is curative and therefore related to treatment of the child's condition. Section 2302 of the ACA provides a new standard of care wherein parents who accept pediatric hospice services can also pursue surgeries and other therapies for their child.

Finally, Be Not Afraid (BNA) offers links to medical journal articles related to prenatal diagnosis and the information shared in this newsletter. Visit the "Research" page at www.benotafraid.net. In addition, in cases in which there is any concern regarding morally appropriate care and treatment, BNA recommends that parents be referred to The National Catholic Bioethics Center (NCBC), which provides free consultations to individuals seeking guidance on the appropriate application of Catholic moral teachings regarding ethical issues arising in health care and life science. Is Carrying to Term Psychologically Safe for Me?

Again, yes. Grief is a natural response experienced by all parents who have lost a baby due to a medical condition. However, studies show that mothers who chose to carry their baby to term recover their baseline mental health more quickly than those who aborted due to fetal anomaly.

Facing a Prenatal Diagnosis: You Are Not Alone

Expectant parents have many hopes and dreams for their baby, and the news of a prenatal diagnosis can come as a shock. Parents often feel as though their entire world has been turned upside down, and suddenly the joy of pregnancy is affected by grief and worry. Doctors, friends, or family may have even urged them to terminate the pregnancy quickly and "try again."

If this sounds like you, know that you are not alone. Other parents have walked this path before you, and compassionate, practical support for parents who carry to term is available. Your baby has not changed as a result of this diagnosis; you just have more information about their needs. (1) Continuing this pregnancy and carrying to term will allow you to honor your child's life and cherish the time you will have together.

What Do Other Parents Do?

Most parents experiencing a prenatal diagnosis want a better option than abortion, and 80% choose to carry to term when offered comprehensive support. (2) In addition, after carrying to term and giving birth, these parents reported that they were glad they chose to carry to term with support and would encourage others to do the same. (2) (4)

Have You Been Offered the Option of Carrying to Term?

Your doctor may not have offered you the option of carrying to term because they may not understand the benefits it provides to parents experiencing a prenatal diagnosis. Remember that your doctor's relationship with your baby differs from your relationship with your baby.

Parents who have carried to term report that the experience of the diagnosis is the hardest part of the journey -- even if the birth results in loss. (1) Ending your pregnancy now at diagnosis can be emotionally and physically traumatic. Don't allow yourself to be rushed into making a decision about your baby's life before you understand all the options. Take time to make an informed decision.

What Help Is Available If We Receive a Prenatal Diagnosis?

Parents carrying to term with a prenatal diagnosis benefit tremendously from comprehensive, life-affirming care that provides practical, emotional, and spiritual support. (2) In reframing the experience, parents honor the child's life and are empowered as parents as they prepare for their baby's birth and whatever follows.

Comprehensive support helps parents find ways to cherish and celebrate the baby's life no matter the diagnosis. It ensures they are fully prepared for all possibilities after birth with no regrets. (3) You will be assisted in obtaining appropriate prenatal and neonatal referrals and preparing a plan for your baby's birth.

Is Carrying to Term Medically Safe for Me?

Yes. Studies have found *no increased medical complications for the mother* associated with carrying to term a baby with a prenatal diagnosis. (2) Carrying to term also allows you to avoid the risks to future pregnancies associated with abortion, including premature birth and low birth weight. (2)

The Knights of Columbus Charitable Trust was established in May of 1991. It has been amended once in 1999 to change the Corporate Trustee First Interstate Bank to Hilltop National Bank. Over the years the Trustees have changed and perhaps with out proper resignations and appointments and we varied from the Trust in purchasing of policies of less than \$150,000 and on individuals rather than priests. The insurance department of the Knights of Columbus would not sell us more insurance as we had not acted within the scope of the Trust. The current Trustees are in the process of bringing the Trust back into alignment with the original Trust document and need to amend it to facilitate current insurance products.

The Trust was set up to purchase 9 year vanishing premium policies, which are no longer available. We need to amend the Trust to allow us to purchase current whole life products. We also had a cumbersome process for the Bishop to appoint a 9 member board for the selection of a priest to be insured. We would like to amend this so the Bishop or his representative can make the recommendation. Once we have the motions to amend, we will have our attorney, Cameron Smith codify (put into legal language) the amendments for inclusion into the Trust Document.

- 1. Motion to affirm the appointment by the elected Officers of the Wyoming State Council Knights of Columbus of Ken Stockwell as Trustee for the Knights of Columbus Charitable Trust.
- 2. Motion to amend Section I and Section III to allow the Trustees to purchase current whole life policies offered by the Knights of Columbus or other reputable insurance companies.

- 3. Motion to amend Section VI to allow the Bishop of the Diocese of Cheyenne or his representative to designate a willing priest or other willing individual on whose life the Trust will use the funds to purchase an insurance policy.
- 4. Motion to clarify and revise Exhibit A with the help of an attorney and the approval of the elected officers of the Wyoming State Council
